**CAPS-DC makes trips to and from health care appointments as easy as calling a taxicab!**

**One-hour service:** Flexibility to make your reservation one hour before your ride is needed.

**One stop pick-up and drop-off:** You do not have to share your ride or make stops before you reach your destination.

**Choice of pick-up and drop-off location:** Trips can start/finish anywhere within the District of Columbia. An eligible medical facility location (see list on the back of this brochure) must be either the pick-up or drop-off location.

**\$5 each one-way ride:** Each one-way trip is \$5, which can be paid by cash, credit/debit card. For many customers, this is less than their MetroAccess fare.

**Companion rider:** Companions are welcome at no additional charge. You may request an additional MetroAccess customer to ride along at the standard CAPS-DC fare of \$5.

**Priority wheelchair accessible taxicab use:** Priority wheelchair accessible taxicab use is given to MetroAccess participants.

**MetroAccess Compatability:** CAPS-DC taxicab drivers require your MetroAccess I.D. number at time of service. MetroAccess Medicaid payment processes remain the same. CAPS-DC participation does not affect your MetroAccess eligibility.
